Field blank results, when available, are used to blank correct results. NIOSH 7400 requires field blanks be submitted at a rate of 10%, with a minimum of 2 per set. Measurement of uncertainty available upon request. The results in this report meet all requirements of the NELAC standards unless otherwise noted. Intra-laboratory Sr values: 5-20 fibers = 0.3, 21-50 fibers = 0.25, 51-100 fibers = 0.21. Inter-laboratory Sr values (Average of EMSL round robin data) = 0.32.
